If any of the WINNING NUMBERS match any of the YOUR NUMBERS, the player wins the prize amount shown below the matched number(s). If the prize symbol for the matching **YOUR NUMBER** is a "\$PIN" symbol, the player can go to NJBIGSPIN.com and enter the 6-digit SPIN REVEAL CODE to spin the Instant Win Spin prize wheel and reveal a prize. Instant Win Spin prizes range from \$20 and \$10,000 or a "BIG SPIN EVENT". If a "BIG SPIN EVENT" prize is revealed the player is qualified for the "BIG SPIN EVENT" to win a guaranteed prize from \$75,000 to \$400,000. Players that do not have access to an electronic device can present the ticket to any New Jersey Lottery retailer to check the prize.

1. **DEFINITIONS** (for purposes of this game):

Backup Wheel - means a second wheel, identical to the Primary Wheel, that will contain twenty (20) slots each indicating prize amounts including and between \$75,000 and \$400,000, as per THE BIGGER \$PIN prize structure.

Big Spin Event – means a scheduled in-person, publicized event in which a Big Spin Event Prizewinner has the opportunity to spin the Wheel for the awarding of a guaranteed prize including and between \$75,000 and \$400,000.

Big Spin Event Prizewinner - means a Prizewinner presenting a Winning Ticket that entitles him/her to be a participant in a Big Spin Event.

Foul - Any circumstance where a spin of the Wheel is deemed to not be a Valid Spin.

Player – means a person at least eighteen (18) years of age, who purchases a "THE BIGGER \$PIN" ticket.

Primary Wheel - means the primary Wheel to be used during each Big Spin Event that contains twenty (20) different slots each indicating prize amounts including and between \$75,000 and \$400,000, as per the prize structure. Except where specifically noted, Primary Wheel and Backup Wheel are collectively referred to herein as a "Wheel".

Prizewinner – means a Player or person who is entitled, as a result of successful verification and play/ticket validation, to receive a prize under the rules of "**THE BIGGER \$PIN**" game.

Proxy - means a person at least eighteen (18) years of age, who is chosen by either a Big Spin Event Prizewinner or the New Jersey Lottery in accordance with these rules, to spin the Wheel on behalf of the Big Spin Event Prizewinner. A Proxy shall not be entitled to any prize and his/her spin result will be final and binding for, and on behalf of, the Big Spin Event Prizewinner. Once chosen by a Big Spin Event Prizewinner or the New Jersey Lottery, the Proxy shall not be changed or terminated.

Valid Spin - means a Wheel spin that has made at least three (3) complete rotations during which no one or nothing touches the Wheel until after it has come to a complete stop. A light at the bottom of the Wheel will be illuminated for each of the three (3) complete rotations.

Winning Ticket – means a ticket for "**THE BIGGER \$PIN**" game that has passed all New Jersey Lottery validation and security requirements.

2. TICKET POOL:

- a) Approximately 6,000,000 **THE BIGGER \$PIN** instant tickets are initially planned for sale in this game. Should additional tickets be introduced, prize levels and frequency of winning will be consistent with the following disclosures.
- b) **THE BIGGER \$PIN** instant tickets are produced in pools of 120,000 tickets. On average, there shall be the following number of prizes:

4. **BIG SPIN EVENT PRIZES**

- a) Each Big Spin Event will be scheduled in advance at a time and place as determined by the New Jersey Lottery Executive Director. The New Jersey Lottery reserves the right to hold the Big Spin Event(s) at a location(s) other than its headquarters office. Travel to/from and attendance at the Big Spin Event shall be the sole responsibility and at the expense of each Big Spin Event Prizewinner and/or his/her Proxy.
- b) If the Big Spin Event Prizewinner is unable to attend the scheduled Big Spin Event, he/she must contact the New Jersey Lottery to schedule an alternate date and time for the Big Spin Event as selected by the New Jersey Lottery. All Big Spin Events must occur within 425 days of the announced end of Game.
- c) A Big Spin Event Prizewinner may elect to designate a Proxy to spin the Wheel on his/her behalf at a Big Spin Event. The Proxy may be selected by the Big Spin Event Prizewinner or by the New Jersey Lottery upon written authorization by the Big Spin Event Prizewinner. The election of a Proxy by either the Big Spin Event Prizewinner or the New Jersey Lottery must be made prior to a Big Spin Event.
- d) A parent or legal guardian of a Big Spin Event Prizewinner under the age of eighteen (18) shall be required to spin the Wheel on behalf of the minor Big Spin Event Prizewinner or select in writing a Proxy to spin the Wheel for and on behalf of the minor Big Spin Event Prizewinner.
- e) If determined by the New Jersey Lottery, prior to or during the Big Spin Event, that the Primary Wheel has or will malfunction(ed), the Backup Wheel will be used for the Big Spin Event.
- f) If it is determined by the New Jersey Lottery, prior to or during the Big Spin Event that neither the Primary Wheel nor the Backup Wheel can be used, the Big Spin Event will be postponed to a date determined by the New Jersey Lottery until both Wheels can be repaired.
- g) The New Jersey Lottery Executive Director reserves the right to postpone and reschedule any Big Spin Event for any reasons, including, but not limited to, inclement weather, public health reasons, security reasons, or any other reason without limitation. In such case the New Jersey Lottery will determine an alternative date and/or location for the Big Spin Event.
- h) Both the Primary Wheel and the Backup Wheel shall contain the following prizes:

5. PRE-EVENT SPINS

- a) The Wheel shall be placed on the \$400,000 prize as the starting position for each spin during the Big Spin Event.
- b) The Wheel shall be tested at least three (3) times by the New Jersey Lottery or its designee. Each test spin of the Wheel must be a Valid Spin and the winning positions and corresponding dollar amounts shall be recorded by the New Jersey Lottery or its designee for each test spin.
- c) After all pre-event test spins have taken place on the Wheel, the Wheel shall be placed on the \$400,000 prize as the starting position for each live spin during the Big Spin Event.

6. LIVE SPIN

- a) The Big Spin Event Prizewinner and/or Proxy, must be present in person for their scheduled Big Spin Event. Each Big Spin event shall be overseen by New Jersey Lottery personnel and an independent third-party auditor.
- b) At the direction of the New Jersey Lottery or its designee the Big Spin Event Prizewinner or Proxy shall spin the Wheel and then step away from the Wheel to a location as designated by the New Jersey Lottery or its designee.
- c) To the extent there are multiple Big Spin Event Prizewinners and/or Proxies at a scheduled Big Spin Event, the New Jersey Lottery or its designee shall, in its discretion, assign the order in which each Big Spin Event Prizewinner and/or Proxy shall live spin the Wheel at the Big Spin Event.
- d) The New Jersey Lottery or its designee shall announce the prize amount designated by the marker on the Wheel. The winning amount is the prize amount to the left of the arrow. The prize amount shall be the amount fully located to the left of the arrow.
- e) The New Jersey Lottery's auditor shall confirm the prize amount designed by the marker on the Wheel and that the spin was a Valid Spin.

- 7. FOULS
 - a) The New Jersey Lottery or its designee may call a Foul and invalidate the live spin of a Big Spin Event Prizewinner or Proxy for any of the following reasons:
 - The Big Spin Event Prizewinner/Proxy touches the Wheel while it is spinning.
 - The Wheel does not make a Valid Spin.
 - An event occurs that prohibits the New Jersey Lottery or its designee from determining that a Valid Spin occurred.
 - b) If a Foul occurs during a spin attempt, the New Jersey Lottery or its designee will announce a "RE-SPIN". The New Jersey Lottery or its designee will then return the Wheel to the starting position of \$400,000 for the live spin and reset the spin revolution lights.
 - c) In the event a Prizewinner or Proxy cause three (3) consecutive Fouls to occur during a live spin, the New Jersey Lottery or its designee will announce "INVALID." The Big Spin Prizewinner's prize amount shall then be confirmed to be \$75,000, and the Big Spin Event Prizewinner shall have no right to any other prize with respect to the Big Spin Event.

8. DEFAULT WIN

In the event that any of the following should occur:

- a) a Big Spin Event Prizewinner is unable or unwilling to designate a Proxy or authorize the New Jersey Lottery to designate a Proxy on his/her behalf within the time specified by the New Jersey Lottery for doing so; or
- b) a Big Spin Event Prizewinner or his/her Proxy is unable or unwilling to attend the Big Spin Event at the location and time specified by the New Jersey Lottery; or
- c) a Big Spin Event Prizewinner has elected to participate by means of a Default Win; or
- d) A Big Spin Event Prizewinner has not attained the age of 18 years of age or older and a parent or legal guardian is unable to spin the Wheel on their behalf or select a Proxy to spin the Wheel on their behalf,

Then the New Jersey Lottery shall award the \$75,000 prize for a Default Win and the Big Spin Event Prizewinner shall have no right to any other prize with respect to the Big Spin Event.

9. GROUP PLAY

a) If the Big Spin Event Prizewinner is more than one (1) individual (a "Group"), the members of the Group shall select a single representative ("Representative") from the Group or an agreed upon Proxy to participate in a Big Spin Event. Once selected, the Representative or Proxy shall not be changed. Each member of the

Group is deemed to represent and warrant to the satisfaction of the New Jersey Lottery that there are no additional members of the Group that may make a claim to entitlement to a prize and all members of the Group must, prior to participating in the Big Spin Event, execute a release confirming the selection of a Representative and/or their election and that the result of such Representative's Spin or the Default Win shall be final and binding on all members of the Group.

10. OTHER

- a) Pursuant to the New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.), holders of Winning Tickets or shares may choose to remain anonymous indefinitely. The identity of a holder choosing to remain anonymous shall not be included under materials available for public inspection pursuant to the New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 et seq. and N.J.A.C. 17:20-7.7). Holders of Winning Tickets or shares may expressly authorize use by or on behalf of the New Jersey Lottery of his or her name, address, prize amount and photographic or videographic likeness, in any medium for the sole purpose of advertising and publicity.
- b) The Game is governed by the State Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1, et seq). The New Jersey Lottery Executive Director has the sole authority to resolve all disputes arising out of or relating to the Game, including but not limited to the Big Spin Event, the Primary Wheel, the Backup Wheel, all Wheel spins and the Instant Win Spin. The New Jersey Lottery Executive Director's decision regarding any and all such disputes shall be final.
- c) As a condition of participating in the Game, you agree to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC (collectively "Affiliates"), from and against all claims for injury, damage and death, and from and against any cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with your (or your Proxy's if applicable) participation in the Game, including but not limited to your (or your Proxy's if applicable) participation in a Big Spin Event, your (or your Proxy's if applicable) spinning of the Primary Wheel and/or Backup Wheel, and the Instant Win Spin; any defect with the Game, including but not limited to the Big Spin Event, the Primary Wheel, the Backup Wheel, and the Instant Win Spin; any error in the administration or operation of the Game, including but not limited to the Primary Wheel and/or Backup Wheel, the Big Spin Event, your (or your Proxy's if applicable) spinning of the Primary Wheel and/or Backup Wheel, and the Instant Win Spin; and your (or your Proxy's if applicable) acceptance. possession, use or misuse of any prize awarded in connection with the Game, including but not limited to the Big Spin Event, your (or your Proxy's if

applicable) spinning of the Primary Wheel and/or the Backup Wheel, and the Instant Win Spin (collectively "Activities"). You, on behalf of yourself and/or your spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to you or your property that you may have against the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective Affiliates arising out of or associated with your (or your Proxy's if applicable) participation in the Activities.
